**The Regular Meeting of the Board was held at 1:30 p.m. in the Commissioner's Chambers/or virtually due to New Mexico COVID-19 orders, with the following present: Bill Lee - Commissioner; Billy Moore - Commissioner; Tommy Nelson - Commissioner; Doug Decker - County Attorney; Anthony Dimas - County Manager; Janessa McMahon - Executive Assistant; Adam Berry - OEM; James Maiorano - Sherriff Dept.; Kameel Bennett - Clerk's Office - Monitor.**

**The meeting was convened at 1:30 pm and called to order by Commissioner Billy Moore. Roll call was taken.**

Commissioner Lee - present; Commissioner Moore - present; Commissioner Nelson - present.

**The Pledge of Allegiance was led by McKinley County Billy Moore.**

1. **DISCUSS, REVIEW and IF NEEDED, AMEND: Ordinance 2020-APR-002: Establishing a ban on the sale of certain alcohol products to aid in stopping the community spread of the COVID-19 Virus; and, urging all citizens to choose to self-curfew during certain hours for the period of the declared emergency: Anthony Dimas, Jr., County Manager; McKinley County; Douglas Decker, Attorney; McKinley County.**

The Commission took comments from the public who called in to the meeting to make the comments. This meeting was placed on the McKinley County OEM Facebook live virtual site, and citizens were capable of calling a number and a return call was made to receive those comments.

Commissioner Lee made a motion to Revoke Ordinance 2020-APR-002: Establishing a ban on the sale of certain alcohol products to aid in stopping the community spread of the COVID-19 Virus; and urging all citizens to choose to self-curfew during certain hours for the period of the declared emergency. Commissioner Moore seconded the motion. Motion Carried.

Commissioner Nelson "Said I", Commissioner Lee "Said I", Commissioner Moore "Said I". None - OPPOSED.


